With his/her signature, the applicant, or the legal guardian(s) if the applicant is under 18 years of age, declares his/her membership and undertakes to comply with the statutes and regulations, in particular to pay the membership fee on time in accordance with the membership fee regulations and to support the objectives of the association. The Executive Committee may unanimously expel a member if he/she has not paid his/her dues for six months despite a written reminder and the threat of expulsion.

Start of membership / calculation of contributions:

The date of entry is the date of signature. The calculation of the membership fee starts from the date of entry. **The admission fee of 20 Euros is due after entry.**

Upon admission to the club, I become aware of and expressly accept the statutes and regulations of the association and the contribution rates.

Resignation / Termination:

Resignation is possible at the end of an annual quarter if it has been declared in writing to the Executive Board at least four weeks before the end of the quarter. In justified cases, the Executive Board may allow exceptions to the deadline.

SEPA Direct Debit Mandate / Pre-Notification / Due Date Notification:

A SEPA direct debit mandate shall be concluded with the payer for the collection of membership fees. The fees are due **monthly** in advance by direct debit. The due date occurs without a reminder. Membership fees and contributions shall be collected by direct debit. Upon joining the club, the member undertakes to issue a direct debit mandate for the period of membership and to ensure sufficient cover for the account drawn upon.

Fees:

All fees incurred in connection with a return debit note of any kind shall be borne by the account holder. The reminder of possible outstanding debts is free of charge, for subsequent reminders further fees will be charged by the association.

Accident insurance:

Through membership, the member is insured in a sports accident and liability insurance by the Hamburger Sportbund (HSB). However, this insurance can only be claimed if the current club fee has been paid.

Privacy Notice:

I agree to the storage, transmission and processing of my personal data for association purposes in accordance with the provisions of the German Federal Data Protection Act (BDSG) and the regulations of the association's statutes. I have the right to obtain information about my personal data from the association at any time. My data will be deleted after I have left the association.
